

Election Workers Employment Opportunity



Starland County is seeking workers for Monday, October 20, 2025 municipal election.

Successful candidates will be required to manage the election process which will include greeting voters as they arrive to vote, ensuring proper voter forms are completed, assisting with the voting process, asking questions of voters and counting ballots at the end of the day. Successful applicants will be required to work 12-14 hours on election day. There will be two election workers at every voter station and you must work together to fill in forms and ensure everything is completed properly.

The required qualifications for this position are as follows:

- 18 years of age or older
- Availability to work on the Election Day, Monday, October 20, 2025 from approximately 8:00 a.m. to 9:00 p.m. or until the votes have been counted.
- Available to attend an approximate 3 hour training session on October 9, 2025 from 6:00 p.m. to 9:00 p.m.

Previous experience in working elections would be an asset, however training will be provided. If this opportunity is of interest to you, please complete the "Application For Election Workers" and return it to the address below no later than **Friday, September 19, 2025**.
