CAO Report

Chief Administrative Officer Ross Rawlusyk reviewed his CAO Report with Council. Highlights of his report included the following:

- The Administration Staff has been very busy working on information for the preparation of the 2011 Audited Financial Statement. Shawn Frenette from SSCR Corporate Solutions worked with us on the preparation of the TCA Asset information which was then tied into the final audit numbers. The audited statement will be presented to Council by Tim Ell from Endeavor Accountants at the next Council meeting in April.
- An agreement is now in place with Community Futures Big Country to provide us with Economic Development Officer functions for the next year. Our Economic Development Officer, Jordan Webber, commenced working on this function as of April 1st, 2012 and will be working approximately 20 hours per week on trying to achieve the priorities that were set out in our Economic Development Plan.
- The cost estimate information for disaster funding has been submitted and we are awaiting approval for same.
- Council reviewed a summary of radio tower options available to us in the North-Drumheller area. Alberta Agriculture approved funding in the amount of \$73,500.00 to cover components of land

acquisition, tower purchase and also included GPS equipment to increase accuracy of farm based tracking equipment.

- The office construction is still ongoing. A deficiency list has been compiled and Reed Atwood is currently in the process of scheduling their sub-trades so the remaining work can be completed in just one visit. He has also been working on interior and exterior signage and has approved the exterior design.
- The grant claiming for 2011 has been completed and between the MSI Grant and the green component of the Gas Tax Grant, the Administration Office has been totally covered by grant funding. In fact, there is some Gas Tax revenue left over and a new application was completed to re-allocate these funds to some rural water line expansion projects.

- AENV audited four of the water systems within the County.
 These audits are conducted annually and the remaining water systems will be audited later in the year;
- He will be setting up a trial operations project later this week on the Morning Glory Water System after completing an inspection of the system to ensure our initial compliance requirements are satisfied;
- He has been working on the Fire Protection Master Planning document, including input from the fire chiefs regarding priority and overall direction of the fire services within the County;
- The County is presently under a fire restriction notice. This was implemented due to the dry conditions and high winds earlier last week;
- He met with Atco Electric to discuss the construction of the Coyote Lake to Michichi Creek power line project slated for this year;
- The overhead door on the Craigmyle Fire Hall was replaced. In addition, an overhead door was installed on the old shop storage building in the yard and repairs were done to the overhead door on the ASB shop that was installed improperly; and
- Bruce Mackenzie from Alberta Emergency Management held a workshop at the County Office on incident command system training.
