CAO Report

Chief Administrative Officer Ross Rawlusyk reviewed his CAO Report with Council. Highlights of his report included the following:

- The Minister of Environment and Sustainable Resource Development and Stewardship announced the approval of the Lower Athabasca Regional Plan. This Plan is set to guide growth and maintain a healthy environment within the lower Athabasca region for the next 50 years. It becomes effective on September 1st, 2012 and includes regional environmental limits for air, surface and water quality and a regional groundwater management framework with interim triggers.
- The County is presently working with the AAMDC and their partner, 8760 Cellular, for a cellular expense management program. They are to provide a detailed assessment of current cellular arrangements, add clarity to cellular carrier invoices, provide summary statements, an online dashboard report that outlines usage trends, cost breakdowns and extraneous usage.
- The tax deadline for payment of Starland County property taxes is September 30th. However, as the 30th is a Sunday, payment will be accepted until 4:00 p.m. on October 1st.
- Palliser Regional Municipal Services is working on a new Land Use Bylaw for the County. The new draft will feature additional definitions to add clarity, some additional land use districts to allow for some new uses following re-designation, and some new general land use regulations for newer developments like wind energy and on-farm energy general projects.
- The Starland Regional Water Authority met on August 22nd, 2012 to review operations of the Authority. Financially the Authority is in excellent shape and now has a total of \$148,641.00 in accumulated unrestricted assets.
- The Fire Departments have experienced some issues with billing Alberta Transportation for fire call incidents on the highways.

Transportation is trying to get the billing changed to 15 minute intervals, utilizing 911 dispatch log or call out sheets. CAO Rawlusyk will follow-up with Alberta Transportation on this issue to discuss our concerns.

- Thanks to Dorothy for coordinating our recent technology update in the Office and Public Works. She worked the full weekend with Bindu from Trinus to get everything up and running.
- Thanks also, to Sharon, for the diligent work she did on completing our interim Safety Audit. This process is very time consuming and the report preparation is very extensive as well.
- ATCO has offered us about 200,000 cubic metres of fill material that we could use on the Russel slide project.
- Ross attended the Suncor presentation in Delia on the 15th of August. Suncor will be submitting a development permit application sometime in September for this project.
- Playground construction has started in the Michichi campground and they will commence the playground at the Starland Recreation Area after the long weekend.

Attendance of PWS Pratt & Safety Coordinator White At 9:50 a.m., Public Works Supervisor Al Pratt and Safety Coordinator, Sharon White, attended the meeting.

2012 Health & Safety Audit Report

Sharon discussed her Executive Report on the Health and Safety Audit which she recently conducted. She noted that overall the County has shown a good commitment to Safety and obtained an overall score of 89%, passing our Audit and maintaining our COR status. Sharon also noted areas to focus on for improvement. At 10:30 a.m., Sharon departed from the meeting.

Public Works Report

Public Works Supervisor Pratt reviewed his Public Works Report with Council. Highlights of his report included the following:

- Crews have been brushing out trees on back roads for movement of farm equipment;
- Work was completed on the bleachers, etc. at the Starland Recreation Area;
- Hearing tests were done on August 15th, 2012;
- The road crew is nearing completion of the Princeton Road, with finishing work to be done on the last 2 miles. They will be moving to the Munson Transfer Station Road at the end of the week;
- 99 miles of the 2012 gravel program has been completed, being over half of the total program;
- Al met with Corner Stone and Stantec in Red Deer for a prestartup meeting in regards to BF13425;
- The new Kenworth T800 truck arrived last week and will be getting decals and wet kit installed this week;
- He contracted John Rew to grade 11 miles of roadway for the County after the rain on Friday, to try to cut some washboard out;
- Special Areas have been using calcium chloride on some intersections that are usually washboard. All checked these sites out and suggested that the County try this method on some of the trouble spots.

This exchange took place this summer with Ontario members visiting Alberta for 10 days in July and Alberta members visiting Ontario for 10 days in August. All the participants thoroughly enjoyed this exchange program and the representatives extended their thanks to Starland County for the support received from the County. At 11:35 a.m., the 4-H Representatives departed from the meeting.

AAMDC Fall 2012 Convention Program CAO Rawlusyk provided Council with a draft copy of the AAMDC Fall 2012 Convention Program. He noted that the AAMDC Mayors and Reeves Meeting will be held on November 12th, 2012 from 5:15 p.m. to 6:15 p.m. at the Shaw Conference Centre.

CAAMDC Fall Zone Meeting The CAAMDC Fall Zone Meeting is being hosted by Wheatland County and will be held in Rosebud on Friday, October 12th, 2012, commencing at 10:00 a.m.

Lease Agreement between Morrin Foods & County Administration Office CAO Rawlusyk discussed the area between the County Administration Office and Morrin Foods. The County leased this area during the construction period of the office and now that construction is complete, the area has been landscaped. CAO Rawlusyk suggested that we lease this area for a further five year period, to maintain the landscaping in good repair and appearance.

Approval of Lower Athabasca Regional Plan Correspondence was received from the Alberta Government advising that the *Lower Athabasca Regional Plan* has now been approved. This is Alberta's first of seven regional plans committed to under Alberta's Land-use Framework and takes effect September 1st, 2012.
