BYLAW NO. 2006 OF STARLAND COUNTY IN THE PROVINCE OF ALBERTA, CANADA

A Bylaw of Starland County, in the Province of Alberta, for the purpose of revising Bylaw 2003 – Nuisance Abatement Bylaw, under the provisions of Section 63 of the Municipal Government Act.

WHEREAS, Section 63 of the Municipal Government Act, Chapter M-26 of the Statutes of Alberta, as amended, notes that a Council of a municipality may, by bylaw, revise any of its bylaws or any one or more provisions of them;

AND WHEREAS, under this Section, a revision may make changes, without materially affecting the bylaw in principle or substance to correct clerical, technical, grammatical or typographical errors in a bylaw;

AND WHEREAS, Starland County wishes to revise Part 7 of Bylaw 2003 – Nuisance Abatement Bylaw;

NOW THEREFORE, the Council of Starland County in the Province of Alberta, duly assembled; hereby enacts as follows:

- 1.1 This Bylaw shall be known as the "Nuisance Abatement Revising Bylaw".
- 1.2 That the title of Part 7 within Bylaw 2003 be changed to "Appeal to the Court of King's Bench,"
- 1.3 That section 7.1 within Bylaw 2003 be changed to read as "Any Person affected by the decision of the CAO under section 6.1 may appeal to the Court of King's Bench of Alberta pursuant to Section 548 of the *Act.*"
- 1.4 This Bylaw shall come into effect on the date of the third and final reading.
