

BY-LAW NO. 877 OF THE MUNICIPAL DISTRICT OF STARLAND NO. 47
IN THE PROVINCE OF ALBERTA, CANADA

A By-Law of the Municipal District of Starland No. 47, in the Province of Alberta, Canada, to prohibit the discharge of Firearms within designated areas of the Municipal District of Starland No. 47.

WHEREAS, Section 156 of the Municipal Government Act, R.S.A., 1980 and amendments thereto, authorizes the Council to pass by-laws, subject to the approval of the Minister of Municipal Affairs and the Associate Minister of Public Lands and Wildlife, prohibiting the discharge of firearms within designated areas of the municipality.

NOW THEREFORE, the Council of the Municipal District of Starland No. 47, in the Province of Alberta, duly assembled enacts as follows:

1. No person shall discharge or suffer the discharge of firearms within the areas designated in Schedule "A" attached hereto and forming part of this by-law.
2. Section 1 does not apply to:
 - (a) A member of the Royal Canadian Mounted Police or any other Peace Officer who is authorized by the Government of Canada or the Government of Alberta to carry a Firearm and who is required to use or discharge such firearm in the operation of his duties as Peace Officer;
 - (b) Wildlife Officers and Game Guardians appointed pursuant to the Wildlife Act;
 - (c) A person who has been appointed as a municipal pest control officer for the Municipal District of Starland No. 47;
 - (d) A person who discharges a firearm at a shooting range or gun club in the designated areas which have been approved by the Council of the Municipal District of Starland No. 47 for this purpose.

1. THE MICHICHI RECREATION AREA - with the W 1/2 19-30-18-W4 as shown on Plan R.W. 161 containing approximately 81.46 acres more or less
2. THE MCLAREN DAM RECREATION AREA - within the S.W. 1/4 23-33-18-W4 containing approximately 70.0 acres more or less
3. THE STARLAND RECREATION AREA - within the N.W. 1/4 15-31-21-W4 and the N.E. 1/4 16-31-21-W4 containing approximately 101.0 acres more or less
4. THE STARLAND DAM RECREATION AREA - within the N.W. 1/4 26-32-21-W4 containing approximately 56.82 acres more or less
