Approval of Minutes

CAO Report

Chief Administrative Officer Ross Rawlusyk reviewed his CAO Report with Council. Highlights of his report included the following:

- Starland County personnel assisted the Town of Drumheller this past weekend after a State of Emergency was declared due to forecasted flooding. Glen and Ross assisted in the E.O.C., while Al, Stan and Doug all directed crews as they built up areas in Drumheller that were deemed susceptible to flooding. Brenda visited the potentially affected parties in Starland to alert them to the potential river flooding. The Munson Fire Department also assisted with evacuation notices and manning road blocks in Drumheller. The river peaked higher than expected at 1,320 m³ per second, however, the flood abatement measures worked for the most part. Ross commended all staff that assisted for putting forth a superb effort.
- As part of the process for updating the Starland County Road Study, we will be doing traffic counts at selected intersections throughout the County in July and August. Counts will take place from Tuesday to Thursday every week in order to get maximum traffic volumes and will be counted between 6 a.m. to 9 a.m. and again from 3:30 p.m. to 6:30 p.m. Data will be gathered on both the total quantity of traffic as well as the types of vehicles.
- The Village of Delia is doing a large sewer replacement program and also removing and cleaning up a couple of petroleum tank contamination areas at the same time. Starland Seed Cleaning Plant would like to remove a buried tank they have on site and Ross spoke to the company that is doing the soil testing and field support for Delia's program, Parkland Geotechnical, to discuss the possibility of this firm doing the environmental work for the Seed Plant program. Ross suggested that the County could provide staff and equipment to get the tank dug out if the Seed Plant was able to cover the cost of the environmental work.

- Tax and assessment notices for Starland County are being mailed out this week. Property assessments can be appealed anytime within the first 60 days after the notices have been mailed. As such, residents have until August 26th, 2013 to appeal. Taxes are still due by the end of Monday, September 30th, after which a penalty of 8% will be applied.
- At the recent FCSS Board meeting, the Board discussed a letter from Prairie Land Regional Division #25. PLRD requested a meeting to discuss the possibility of adding an additional FRW position in our schools. They feel that the additional help might be needed to address a wide array of complex issues that are being addressed by this front-line service. The Board agreed that they need to look at this request and Diana and Ross will be meeting with Cam McKeage this week to discuss possible solutions.
- The final tender design for the CLV Water Project is nearly complete and we hope to get the project to tender sometime within the next two weeks. We hope to order some meter pits in advance to help speed up the construction process.
- Our new solar portable power station (CLV Project) has been completed and Rick Dunsmoore has asked for permission to make the unit available to the Town of High River for the disaster relief program. They need power in one of their fire halls and the unit has been working well for their needs.
- Community Futures Big Country has requested that we sponsor two students, one from each of the Morrin and Delia Schools, to attend the Alberta Youth Entrepreneurship Camps. Our total commitment would be \$1,100.00.
- Ross has attended the first of two meetings for the Minister's Awards for Municipal Excellence. Ross is one of the panellists that are reviewing the applications.

Information received from them was varied, with capacities and peaking hours changing often. This made it difficult as to what to expect and how to be prepared.

2013 Tax Note & 2013 Budget

CAO Rawlusyk reviewed the 2013 Tax Note that was prepared and will be accompanying the 2013 Tax/Assessment Notices. In addition, copies of Starland County Budget 2013 were distributed to Council for their reference.

Local Authorities Election Act Amendments

Returning Officer Kreke reviewed an Information & Interpretation Bulletin received from Alberta Municipal Affairs with regards to the amendments to the Local Authorities Election Act. A few of the amendments of note include the following:

- *Term of Office* The term of office for local elected officials has been increased to four years from three as in previous elections.
- Voter Identification and Eligibility Section 53 now includes a
 requirement for a person to provide proof of identity and current
 residence in order to vote, unless the elected authority prepares a
 list of electors and the person's name appears on the list. The
 section sets out a basic requirement consisting of a single piece
 of identification that includes the person's name and current
 address.
- Nomination Requirements Section 28 (3.01) was added to clarify
 the responsibility of the returning officers if a nomination form is
 not signed by the required number of electors. If the nomination
 form is not signed by at least the minimum number of electors, the
 returning officer shall not accept it.

Economic
Development
Initiative re:
Solar Installations

CAO Rawlusyk and Special Projects Manager Kreke discussed the economic development initiative to encourage solar projects within Starland County, which was developed through the Starland Regional Economic Development Committee. Their application for funding was approved in the amount of \$50,000.00 and all work involved should be done between July 1st, 2013 and January 31st, 2014. The Consulting Agreement between Alberta Municipal Services Corporation and Starland County was reviewed as well as establishing an incentive package from Starland County for solar development.

BluEarth Renewable Inc. Re: Update on Wind Farm Project CAO Rawlusyk provided Council with an update on BluEarth Renewable Inc. Hand Hills Wind Project. BluEarth made a presentation to its stakeholders on June 12th, 2013 in the Delia Community Centre.

Approval for Approach onto SH576

Approval was received from Alberta Transportation for two *Roadside Development Permit Applications* submitted by the County. Roadside Development Permit No. P2528, which is for the proposed access construction on the NW 7-29-16-W4M off of Highway 576 into Alois Zipper's Gravel Pit was approved. The construction of this new access will provide better and safer access into the County's gravel supply at this site.

Approval for Approach onto SH849

The second Roadside Development Permit No. P2530 authorizes the County to make access improvements into the Michichi Cemetery off of Secondary Highway 849. These improvements will provide a safer approach into the cemetery and also allow for better landscaping opportunities.

Damage Claim re: Ed Gagnon Council reviewed a damage claim received from Ed Gagnon, Saskatoon, Saskatchewan. He noted that his car was struck by a clay ball from a Starland County truck, resulting in a scratch and dent to his 2010 Blue Dodge Charger on Monday, May 27th, 2013. The estimate of damages totalled \$870.34.

They note that this proposal includes the removal of the existing cement sidewalk, excavating and preparing a swale to allow for proper drainage, placement of re-bar, gravel and drainage pipe in the swale and construction of a board walk to be placed over the swale. The total cost to complete this project is in the amount of \$53,200.00.
