Attendance of Acting PWS Pratt & PW Report At 10:00 a.m., Acting Public Works Supervisor Pratt attended the meeting and reviewed his Public Works Report with Council. He noted that crews are in full swing with road construction, regular maintenance issues, road repairs, hydro-vaccing, equipment repairs, road gravelling, working on the Ducks Unlimited Dam, etc. Also, the new end dump trailer and the new pintle hitch trailer have now been received.

Ducks Unlimited Beaverpond Project CAO Rawlusyk reviewed the *Memorandum of Understanding* for the Beaverpond Project Rebuild, for the Ducks Unlimited Dam on the Michichi Creek east of Morrin. DUC were in the early process of plans for decommissioning the works, however, Starland County expressed interest in rebuilding (in conjunction with DUC) and taking over this project (and its license) for municipal purposes including emergency fire control water and storage. Starland County is pursuing acquisition of the land where the dam is located and is working on a redesign and replacement of the spillway in a manner consistent with Alberta Environment standards to meet the requirement for licensing amendments. The local landowners wish to see the project continue and have verbally agreed to provide the necessary access to proceed with this work.

Gravel Pit Environmental Approvals CAO Rawlusyk reviewed information received from Stantec Consulting Ltd. with regards to actions required to obtain environmental approvals on Starland County's gravel pits. His recommendations were to proceed with gravel testing, surveying, mapping, pit plans and reclamation as required on the Starland, Marshall and Handhills-Courtney Pits in 2012; and that the Bund and Morton Pits be scheduled for 2013. Completion of these actions will provide the necessary information to proceed with the County's application for environmental approvals.

Baxter Drainage Issue

CAO Rawlusyk reviewed the scope of work as outlined by Stantec Consulting Ltd. for the Baxter drainage problem. Council discussed this issue extensively and requested Public Works Supervisor Pratt to survey this area himself and report back to Council with his recommendations on same.

Buffalo Jump Contracting Ltd. Re: Gravel Correspondence was received from Buffalo Jump Contracting Inc. They are proposing to crush more gravel at the Scollard Pit late this summer or early fall. However, the crushing contractors advised that there will be an increase in crushing costs due to the large size of some of the rocks, as well as gathering the remaining material to crush. The proposed cost will increase from \$9.98/tonne to \$10.48/tonne for approximately 60,000 to 70,000 tonnes of 20mm or 40mm gravel.

Attendance of Manager Riep & Municipal Services Report At 11:05 a.m., Manager Riep attended the meeting and reviewed his Municipal Services Report with Council. Highlights of his report included the following:

 Regular maintenance continues in the campgrounds, hamlets and cemeteries;

- Crews have now taken First Aid Training;
- The submersible well pump was replaced at the Rowley Truck Fill Station:
- The Rumsey Sewer Lift Station experienced a failure as well as the alarm failed due to vandalism;
- The Munson Fire Truck is now back in service after experiencing some tank problems:
- Gino and Glen attended a regional meeting of the water operators within the Drumheller water source service area. The meeting was to discuss operational issues within the system and to improve on the intercommunications amongst the stakeholder group. The THM problem as well as color complaints were discussed;
- The rural truck fill stations have been extremely busy this season and have caused several of the stations to be out of water from the heavy demand;
- The Canadian Mint changed some of the new coins which will cause problems with our coin operated truck fill stations. Glen noted that our supplier is working to come up with a solution to this problem.

Water System **Upgrading Project**

CAO Report

Correspondence was received from the Natural Resources Conservation Board (NRCB) advising that Application No. RA11054 received from Hutterian Brethren of Neu Muehl, to construct and operate a new 60,000 poultry broiler operation was approved.

CAO Rawlusyk reviewed Starland County's Building Canada Fund Application. He noted that this application was submitted in 2009 and they have indicated that this application may receive late approval this year which would provide funding for the CLV Water System Upgrading Project. The improvements outlined in our application would increase system efficiency, reduce operating expenditures, add additional water users to an existing system and generally improve water administration on the CLV system. In conjunction with this project, the County was asked to provide an updated report for the CLV Water System Distribution System Upgrading, which MPE Engineering Ltd. provided for Council's review. The total upgrading costs are approximately \$1,255,000.00.

At 11:50 a.m., Manager Riep departed from the meeting.

Chief Administrative Officer Ross Rawlusyk reviewed his CAO Report with Council. Highlights of his report included the following:

- The County is awaiting final approval for their Building Canada Fund Application for the CLV Water System Upgrading Project;
- A detailed deficiency list was compiled with regards to the Administration Office construction. There are many deficient items, including two major issues involving the roof collecting and ponding water in several spots and windows that haven't been totally sealed and are leaking. The signage is now completed and he is gathering quotes on finishing the landscaping. The parking area to the east of the building also needs to be levelled.
- He has been doing some research into upgrading the internet speed at the office and public works shop;
- Tax notices have been prepared and are to be mailed out on June 27th, 2012;
- He met with Jon Ohlhauser of Hope College who outlined the planned health care program offerings for the College. They plan to have an Allopathic stream and a Naturopathic stream of training. They are proposing to use 15,000 sq. ft. of the old St. Anthony School building;
- Community Futures Big Country requested that the County sponsor two students, one from each of the Morrin and Delia Schools, to attend the Alberta Youth Entrepreneurship Camps, in
