#### C22-001 Agenda Approval

#### CAO Report

CAO Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- Eddie Bourque, Drumheller RCMP, informed us the Policing Committee was disbanded and the Town of Drumheller is looking to establish a new committee, but it will be exclusive to those residing within the town. Bourque hopes to commence regular Town Hall Meetings in the rural Counties and Villages once Covid has settled and noted that if there is a need, we could have discussions in regard to forming a Citizen's Advisory Policing Committee for our rural areas.
- County is seeking costs associated with the possible re-purposing of the old Public Works Office trailer to be used as a library in Rumsey.
   If this route is pursued, one of the costs that would fall to the county is having the SuperNet connection moved to the new location.
- Reeve Wannstrom and CAO Bremer attended the Zone 2 CRMA Director's meeting virtually on Friday, January 7<sup>th</sup>, 2022. Crystal

Kissel from Rocky View County is the new chair and Barb Shepard from Lacombe County is the Vice Chair. Councillor Watts is now on the resolutions committee. The Spring Zone Meeting will be hosted in Red Deer on February 4<sup>th</sup>. Starland County will be hosting the Fall Zone Meeting on October 7<sup>th</sup>.

- County crews are preparing for the demolition of the Anthony Kloster house that was purchased a few years ago in Morrin. Wise Abatement will handle the asbestos removal on January 17<sup>th</sup> and demolition permits have been applied for as well as requests to confirm all utilities are disconnected. Public Works will then do the demolition and the material being hauled to the landfill in Drumheller.
- The inventory audit will be completed by Ascend personnel this week on Friday. They will audit all the parts, etc. from the Public Works, Utilities, and ASB Departments.

Brownlee Emerging Trends in Municipal Law Seminar Brownlee is offering a seminar on Emerging Trends in Municipal Law. The date of the Calgary session conflicts with the in-person Alberta Police Transition sessions Council and staff were registered for. As the Alberta Police Transition session will happen virtually on a later date, Council and senior staff will go to Brownlee in Calgary except for Legislative Services Director, Carlson who will attend the session virtually on the 17<sup>th</sup> due to a conflicting schedule. Of course, Covid may alter in-person sessions and attendance can be adjusted accordingly.

PERC & DIRC Application

As noted in our last meeting, the County can now apply for the Provincial Education Requisition Credit (PERC) and Designated Industrial Requisition Credit (DIRC) without having to write off unpaid taxes. However, if the property tax has not been expensed as bad debt and written off, there must be a motion from council confirming submission of the PERC/DIRC applications. The companies that are behind on their taxes are Alphabow Energy Ltd. and Tallahassee Exploration Inc.

Amended Water Rate Change Bylaw In early 2019 Council introduced Bylaw 1137 which governs the provision of water utility services in Starland County. Schedule C of this Bylaw outlines the rates charged to customers which may be updated by amending this Bylaw. As proposed in the spring of 2019, the eventual goal was to recover 100% of the supply costs of water (as represented by cost of water, power and goods) as well as 50% of capital replacement costs (as represented by water system annual depreciation).

Bylaw 1180 was presented with the new water rate changes as recommended. Corporate Services Manager, Fazekas also provided a Water Revenue and Expense Analysis for 2020/2021.

Councillor Watts suggested looking into water meter installations in Rumsey and whether that might reduce expenses by helping to pin point water leaks.

Drumheller and District Seniors Foundation

The Drumheller and District Seniors Foundation (DDSF) has submitted a requisition under Section 7(1) of the Alberta Housing Act, for a total of \$985,000.00 from municipalities of which Starland County's portion will be \$401,092.00. In accordance with the Alberta Housing Act, the County has 90 days to pay the requisitioned amount after being notified.

Alberta Municipal Affairs Starland was informed of a potential opportunity for Council to meet with the Honourable Ric McIver, Minister of Municipal Affairs at the 2022 RMA Spring Convention. If Council would like to meet with Minister McIver during the convention, they must submit a request by email including one specific policy item or issue they would like to discuss. As not all requests can be approved due to time constraints, municipalities submitting meeting requests will be notified at least two weeks prior to the convention as to the status of their request.

Economic Development Seminar for Elected Officials Palliser Economic Partnership, the Regional Economic Development Alliance (REDA) for Southeast Alberta has invited Council to attend an Economic Development for Elected Officials Seminar on February 2, 2022 from 9:00 a.m. to 3:30 p.m. at the Hanna Community Centre. Reeve Wannstrom and Councillor Landry are on the Council's Economic Development committee, but all councillors showed interest in going. Other than travel there are no costs for the seminar. As Starland is looking to focus on economic development to diversify industry in our area there were questions on whether senior administration staff could also attend.

Last year he was focused on small towns and this year is looking to do broader history of counties, municipal districts and larger areas around communities. Grader Engine Coolant Heaters Councillor Rew was interested if the County's graders used engine coolant heaters or just the standard block heaters. Engine coolant heaters make it easier on the motors and only require about 2 hours of run time. He has used this on his own equipment and highly recommends them. Hardware is about \$900.00 and there are a few different brands to choose from. The County could handle the installations. CAO Bremer will look into what is currently being used on our graders.

### Columbarium information

CAO Bremer received some columbarium material samples and information that was shared with council. Two providers were very helpful. One company located in Ontario has their own quarry and manufacturing, meaning nothing is imported and they were considerably less money but do not include installation. Bremer was given more specifics on what was wanted in a columbarium to help narrow down and better compare the final costs between the vendors. The specifics Bremer are to look for are:

- 24 standard size niches (12"x12")
- Square/Rectangle shaped columbarium
- 12 niches on front and 12 niches on back
- Solid granite construction
- Light coloured sides and dark coloured niche coverings/fronts
- All installation requirements, recommendations, and costs
- Planning costs around it being installed in the Rumsey Cemetery

Staff Sick Policy Temporary Changes due to Covid Concerns were raised at the Starland Safety Committee Meeting that the County's current sick leave policy requires staff to provide a doctor's note if they are missing 3 or more days due to illness. With the Covid Omnicron strain outbreak, staff are being asked to use sick days if they are showing any symptoms. As rapid tests are in short supply and Alberta doctors are currently not wanting to see anyone who only has cold symptoms, Council is being requested to temporarily relax this portion of the sick leave policy.
