Financial Statements Brief overview of current financial statements but as not all year end financials are received only a summary was presented.

CAO Report

CAO Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- Starland County will host a virtual town hall meeting in partnership with the Drumheller RCMP for our rural residents on February 15, 2022 starting at 6:00 p.m. Registration information is on the County website.
- CAO Bremer provided updates on some of the estimated costs it would take if the old public works office trailer was re-purposed to be used as the library in Rumsey. Still waiting for costs to relocate the SuperNet service.
- Demolition of house in Morrin will commence this week and should be completed in a few days. Final landscaping will be completed in the spring after the ground thaws.
- CAO Bremer has been working on several bylaws of which 3 will be included on the agenda today for discussion.
- CAO Bremer has been working on gathering information on our hamlets to forward on to MP Kurek's office for his "Community of the Week" newsletter. Finding information on Michichi has been more

difficult than on the other hamlets.

- The RMA conducted survey on Unpaid Municipal Taxes. As a recap, the overall outstanding taxes owed by oil and gas is \$11,368,936.69 of which Starland has written off \$9,508,636.96 since 2015. The outstanding amount does not include the two companies which have repayment agreements totalling \$1.26M.
- Regarding the amalgamation of Apogee to Pine Cliff Energy Ltd., they both expressed intent to pay Apogee's taxes from 2021. Apogee has paid 1/3 of the total. Pine Cliff then intends to cover the outstanding balance an expediate the repayment to the end of March 2022. The balance owing is \$474,230.81
- The CAO from Paintearth County reached out to see if neighbouring municipalities are interested in meeting once again at our annual regional intermunicipal meeting.
- Dara Kudras is working on a draft tourism brochure for our recreation areas and campsites.
- Village of Morrin is losing yet another business. Western Financial Group will be closing their doors in Morrin as of February 25<sup>th</sup>, 2022. This will be a loss to the community and surrounding area.
- Naloxone Training was held at the office on January 20th, 2022.
- Jason Carlson is working on finishing development on the online fire permit system with intentions of having it in place for March 1<sup>st</sup>.
- Meska Outdoors is interested in booking 2 3 campsites at the Tolman East Campground for his "glamping" business.

2021 Friends of Education Award

Delegation from PLSD Board Chairperson Holli Smith greeted Starland Council, introduced their delegation, and passed on regrets from Cam McKeage, PLSD Superintendent. Smith reviewed the original nomination application which summarized the various contributions and benefits Starland County has made to PLSD programs including:

- Pledging a total of \$400,000.00 towards the construction of both the new Delia and Morrin schools.
- \$60,000.00 annually of funding directed to preserve Family Resource Worker programs
- Financial contribution to CTS Trailers for Morrin and Delia Schools.

The delegation then presented Starland County with the Alberta School Boards Association Zone 5 2021 Friends of Education Award. The award was a replication of an old brass school hand bell.

Delegation from PLSD left the meeting at 9:47 a.m.

Discussion on Rumsey library

CAO Bremer included in her earlier report some of the estimated costs to relocate the old public works administration trailer to Rumsey to serve as a library and possibly post office. We are still waiting for the estimated costs to relocate the SuperNet.

Alberta Provincial Police Service

Councillor Landry attended the Alberta Provincial Police Service (APPS) engagement session. Presenters were unable to answer any questions about gaps in the report's costs and/or plans. Nothing new from what was already learned in the RMA sessions.

Brownlee LLP Emerging Trends Seminar In person sessions were cancelled so there are now only virtual options available. Virtual sessions are booked for February 10<sup>th</sup> and 17<sup>th</sup> which will be hosted at the County office for staff and council to attend.

Village of Morrin, Proposed Land Acquisition CAO Bremer received a letter from the Village of Morrin regarding the Land Acquisition of Lots 6,7,8,9; Block 1; Plan 4110AJ. Starland's request for acquisition of these lots was denied by the Village of Morrin. Starland County

received a request from Thomas Welch to buy these lots back from him as Covid was putting a financial struggle on his business plans. Welch expressed interest in re-purchasing the land back once his business stabilized. A municipality is required to get permission to purchase land if it is within another municipality. The Village denied the sale of these lands to Starland as the Village wanted to keep these properties on the Village's active tax roll.

Delia Municipal Library Grant An email was received from the Delia Municipal Library noting their disappointment in not being approved for funding to their Library from the 2021 Starland County Operational Grants this past year. CAO Bremer noted that these grants are based on a percentage of the amount of utilities paid, however, there has always been consideration given to the libraries as well, based on the nominal utility/operation expenses they submit. Council requested further information from Delia as to what expenses they were responsible to pay from their Board and where funding if granted would be spent.

2022 Cost of Living

The Province of Alberta's 2021 annual inflation rates for Alberta have been published. Historically the inflation rate as of November has been used so it could be approved and allocated for January 1<sup>st</sup>. However, administration was recommending this year that the final yearly COLA rate be used instead. As of November of this year the yearly inflation rate was 4.3%, but the final yearly rate was 3.183%.

Tax Payment Plan

CAO Bremer reviewed with Council draft copies of two separate tax payment agreements. Both agreements have payment schedules that also include estimated 2022 taxes so accounts will be caught up in full by December of 2022.

#### Hamlet Sewer Utility Bylaw 1182

CAO Bremer presented Bylaw 1182 to repeal and replace Bylaw 1063, originally the Water & Sewer Utility Bylaw. This new bylaw is being established to provide for the regulation, operation, and maintenance of a sewer system in the Hamlets, and the levying of rates and charges thereof. The original bylaw, Bylaw 1063 included both water and sewer, but the water portions were all repealed when replaced with the Bylaw 1137. This left a large portion of this bylaw as irrelevant and repealed, making it hard to read and interpret. This new bylaw will provide information only relevant to the hamlet sewer systems and will be easier to interpret and apply.

The rates in the bylaw were unchanged since the original bylaw was established in 2002 making them 20 years old. Council would like this tabled while administration research actual costs and comparative municipality rates.

#### Nuisance Abatement Bylaw 1184

CAO Bremer presented Bylaw 1184 to regulate, control and abate nuisances, including dangerous and unsightly premises. It would repeal our present Nuisance Abatement Bylaw No. 1092 and would now include a definition for loud noises, inclusion of "loud noises" to various sections, and an improved definition for "nuisance" which now includes unsightly premises more specifically. With this improved wording, this bylaw can more easily be enforced.

After some discussion, it was decided to table the discussion and consider the following changes:

- the "Noise" definition was too vague and opened it up for abuse
- need to remove "vehicles" from "Noise" definition
- section 3.6 needs to also include "or Designated Officer"
- have consistent times 7 days a week, 10:00 p.m. until 7:00 a.m.

#### Ember Resources Refund

Ember Resources Inc. has made a request for a refund on a tax payment they made on a property that does not belong to them. They noted the property was not theirs but paid it to avoid tax penalties while they waited for confirmation. Ownership of the property is being put back in the name of Trident Exploration and was never purchased by Ember Resources Inc.

MCCAC EV Charging Station Grant The Municipal Climate Change Action Centre (MCCAC) has a grant opportunity. The Government of Canada, with matching funding from the Government of Alberta is providing access to grants to invest in electric vehicle (EV) charging stations. Jason Carlson has identified two potential locations that would be a good fit for the grant requirements and has already submitted a non-committing Expression of Interest letter as per the first step of accessing the grant. Starland County is currently in the centre of a large void where there are no EV charging stations available which is likely discouraging drivers with electric vehicles from participating in all our County has to offer. The next stage is to get quotes and put together proposals that best fit the needs in our region.

MSL Grant for Docks at Michichi and McLaren Campgrounds Dara Kudras has identified a possible grant from the Minister's Special License (MSL) Program that may assist the County in installing new docks at the Michichi Campground and McLaren Dam Campground. The Government of Alberta and the Minister of Environment and Parks makes the MSL program possible through auctions on donated items. Kudras has submitted separate applications for each Campground already as the deadline for application was January 31, 2022.

Enterprise Fleet Management Proposal Judy Fazekas went over an introductory proposal from the Enterprise Fleet Management company where they claim we could reduce our total fleet costs by using them to manage our fleet. They buy and sell a very large number of fleet vehicles every year and have analytics to bring as much value to a fleet by knowing the best time to sell a vehicle. Using basic information about our fleet they are suggesting we could save \$348,762 over 10 years and have newer vehicles in our fleet that require less maintenance.

If there is interest to look into this in more detail they will come and make a presentation to council. Council expressed interest in learning more.

RCMP Reports

Staff Sgt. E. Bourque of the Drumheller RCMP has provided the October 1<sup>st</sup> to December 31<sup>st</sup>, 2021 quarterly report. He has also requested council to identify their top 3 priorities for rural policing by the RCMP and have them ready for when he next meets with council.

2022 Tax Sale

The 2022 Tax Sale currently includes one property in Rumsey. It still needs to have an official appraisal and there will be costs associated with that. The other option is to use the assessor's residential assessment value. If it doesn't sell the county would take ownership and at that time could look at cleaning up the property to help it sell.

FCM 2022 Conference The Federation of Canadian Municipalities (FCM) 2022 Conference and Trade Show will be in Regina this June 2-5, 2022.
