CAO Report

CAO Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- A photographer is scheduled to take new County photos of Council and new employees at our June 22nd, 2022 Council meeting.
- Had a good discussion with RMA representatives that visited Starland County on May 2nd, 2022. Lots of topics were covered and felt our representatives are working hard on these important issues such as working on a new formula for the distribution of the Local Government Fiscal Framework (LGFF) grant, the Assessment Model review, and the unpaid oil and gas tax arrears situations.
- Tim Duhamel's presentation on a tax strategy was both interesting and enlightening. Our alternatives are limited at the present time, however, following the strategies described, the county can move forward and hopefully with a few prospective developments and discussions around new alternatives, we can keep Starland County viable and sustainable for years to come.
- Safety Day at the Starland County office went very well. The keynote presenter, Debra deWaal was well received and helped us prepare for our own safety and was both entertaining as well as informative.

Chris People's and everyone involved did an excellent job providing a great display of teamwork and commitment which was noticed and appreciated.

- The Municipal Administrator's Leadership Workshop that CAO Bremer, CSD Fazekas, and LSD Carlson attended was very informative and educational. Sessions attended were on leadership, property tax collection, Council Codes of Conduct, Infrastructure & Utilities, and Thriving in Today's World.
- Twenty-eight K-2 students from the Morrin School came to tour our facility and appeared to really enjoy themselves with the highlight being able to sit in one of our scrapers and in a grader. We took pictures of them which will be sent to the school for them to take home. Thanks to all who helped out in welcoming them to our facility.
- A discussion a couple months ago in regards to employees utilizing the wash bay after hours for their own personal use was discussed again at the Safety Committee meeting where it was recommended that no one be allowed to wash their personal vehicles after hours due to the liability and insurance issues that could arise.
- Crushing at the Morton Pit is to commence next week. Zulu Aggregates was awarded the tender and they estimate approximately one month of work to meet our crushing needs.
- Supervisors have been working on identifying priorities in our truck fleet that will be replaced under contract with Enterprise Fleet Management. Eleven vehicles have been identified for replacement with most of them being either quite old or of high mileage. Enterprise has the list and is working on getting us estimated costs to move forward.
- In regard to the Broadband Project discussed at our intermunicipal meeting in Byemoor, CAO Bremer would like to get an idea of whether or not we are to pursue this interest before making it a priority of LSD Carlson's time and involvement.
- The Alberta Ombudsman's Office received a complaint from a Kneehill County landowner in regard to Barney's Amusement Park. They have requested to forward copies of correspondence in this regard, including our responses to the complaints received. CAO Bremer will forward this information on as soon as possible.
- For council's information, Doug Luschyk, Road Construction Foreman, will be parking his holiday trailer by the CN building here in Morrin during this construction season.
- The County received an Offer to Purchase on the tax recovery lot in Rumsey, however we will need to wait until the transfer of the title is in the County's name before we can consider the sale of this property.
- Eagle Builders has been on site doing more warranty work on our facility. They have been very responsive and provided extended warranty work, including repairs to some cracks in the cement and drywall, as well as fixing leaky roof issues. Their commitment to workmanship is certainly commendable.

Broadband Project CAO Bremer followed up on her report asking council their interest in this project as discussed at our intermunicipal meeting in Byemoor. Council has asked the County do some preliminary investigations on it to better understand how it would work and whether or not it would be a viable fit for our municipality only having 2000 residents.

Attendance Riley Kloss of Wild Rose Assessment entered the meeting at 9:40 a.m.

Wild Rose Assessment Delegation Riley Kloss of Wild Rose Assessment presented information about how their organization does assessments and the different legislation that guides them. Council had opportunities to ask questions and better understand the system. As Wild Rose Assessment works for multiple municipalities across the province, this gives them very good insight into understanding wider markets and business values which benefits the municipalities they work for.

Outstanding Tax Arrears:
Tallahassee Exploration Inc. & Long Run Exploration Ltd.

Council was presented with outstanding tax arrear repayment proposals from Tallahassee Exploration Inc. and Long Run Exploration Ltd.

Tallahassee has come back with an alternative counter proposal. They want payments to start on June 30th, 2022, with monthly payments of \$50,000 for 15 months and then the final balance paid in full for the 16th month. They agreed to continue paying penalties. They also will pay the 2022 taxes in three equal monthly payments from September to December of 2022.

Long Run Exploration Ltd. sent a cheque to pay their taxes, but it did not include amounts for tax penalties. They included a letter stating if we accepted the payment the County would waive the penalty fees. Council rejected the idea that one can alter an existing previous agreement on the condition of accepting their late payment. However, it was discussed that ignoring their demand even if it would not likely stand up in court could just cause unnecessary delays.

There seems to be a gap in communication and Deputy Reeve Sargent, Starland County representative on their board, will follow up and get clarification.

Auction Follow-up

The auction of County items of no useful value to the County was completed and CAO Bremer presented Council with the value items were sold for. The Auction was held by ClubBid, Century Auctions Online Marketplace.

Community Appreciation Initiative Banners

Banners have arrived and were available in the front lobby for Council to view. These banners will be used when the County sponsors various community group's fundraisers in order to help show our support to organizations within our County.

LGFF Engagement Survey

The County received a Local Government Fiscal Framework (LGFF) survey that needs to be completed soon. Only one survey can be submitted per municipality and some questions are best suited for council and others by administration, so it was recommended we look at the survey together. Prior to filling out the survey, the Rural Municipalities of Alberta (RMA) will be having a town hall meeting today from 3-4pm via Zoom that we will pause our council meeting so we can all attend. This meeting will engage some

discussions to help us better understand some of the challenges this new system brings, in order to be more informed when the survey is filled out.
