**CAO** Report

CAO Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- Lacombe Signmasters has completed the installation of all eight highway signs. Most comments have been quite positive. The signs also reflect nicely in the dark making them easy to see at night.
- Carlson, Fazekas, and Bremer met with Jacqueline Buchanan, East Central Regional Economic Development Specialist for Alberta Jobs, Economy and Innovation; and Heather Schmidt, Senior Business

Officer Community Initiatives, Alberta Region, Prairies Economic Developer Canada on August 29<sup>th</sup>, 2022. Buchanan works for the AB Government while Schmidt works for Federal Government. This initial meeting was to include the Village Administration Reps as well, however, none were in attendance. We discussed many aspects of economic development for our region, including present developments, investment readiness, tourism opportunities as well as information on the Rural Entrepreneurial Integration Stream for a possible gas station, restaurant, etc.

- LSD Carlson and CAO Bremer met with Kevin Gannon and Barb Hazelton from Kneehill County to work on an Intermunicipal Development Plan (IDP) between Kneehill and Starland County. When adopted, the municipalities would have a mutual agreement for a notification process whenever there is development, subdivision, or change of land use within approximately one (1) mile of our shared borders. A copy will be provided to Council and any comment, amendments, changes, etc. need to be submitted by September 21st.
- Councillor Landry, CAO Bremer and Reeve Wannstrom attended the Community Meeting at the Village of Delia on September 8<sup>th</sup>, 2022. It was quite well attended by the village residents and the Town of Hanna attended as well to give their thoughts on Delia's present issues. Many questions were asked about what it may look like if the Village was absorbed into Starland County. Several ideas were discussed, including the possibility of hiring a CAO to manage more than one Village, and then having a clerk hired to do the billings, answer phones, etc. The Delia residents did take a vote to apply to Municipal Affairs for a viability study, which they hope will outline the current state of affairs in the Village.
- Palliser Regional Municipal Services (PRMS) are undertaking a review of their funding formula and once determined it will amend the current PRMS funding model. The goal will be to create a new funding formula that is sustainable and equitable based on their proposed new service delivery model, operating structure and budget resulting from the Palliser Enhancement Project and new proposed strategic plan. Carlson, has attended two of their working sessions on Starland's behalf and the increases will likely be quite substantial. Palliser is hoping to garner the consensus from all the participating municipalities as they have been operating on their reserves for the past few years which is not sustainable.
- Paul Wheeler is working on the County's Fall Newsletter and hopes to have it ready early in October. If Council has any additional suggestions for this publication, please get them to CAO Bremer as soon as possible.
- Two new docks have been installed with one at Michichi Dam and the other at McLaren Dam. They are looking great. Thanks to the staff for getting these installed.
- Received a quote for the historical school signs. The post and schoolhouse shape would be powder coated black with a bronze plate identifying the name and years of the school site. The cost for each sign would be \$1,100.00 plus GST. The plan was to order four each year until all school sites are identified.
- Staff are busy organizing and preparing for the upcoming CRMA Fall Zone 2 Meeting that will be held in Rumsey on Friday, October 7<sup>th</sup>. The hall and caterers have been booked and there is some County swag to hand out to those attending. There will also be 3 baskets of goodies for a draw, and a "to-go" snack bag for each of the members to take for the drive home.
- Glen's crew is now prepping the area for our new columbarium. Once the cement has cured, it will be ready for delivery, which should be in the next couple of weeks. Once we are invoiced by Nelson Granite and factor in our costs for the site prep, the total costs will be reviewed to determine a sale price for each niche as well as a cost for the plaques on the memory wall. There has already been some inquiries and the plan is to label the columbarium niches, so people can

choose the niche they want.

- We need to start looking at 2023 budgets and would like to set a
  meeting date to review our Strategic Plan and our Vision Action Plan
  to update as needed. Also discuss the major projects and capital
  plans that we would like to achieve in the upcoming years.
- Another approaching issue is the County needs to address our lease agreements that we presently hold with several of our ratepayers who are leasing the crown land that the government turned over to the County. They had a 5-year lease with the option to purchase once the lease was done, or to renew with another lease agreement if they have extenuating circumstances.
- Her Majesty Queen Elizabeth II will be laid to rest on Monday, September 19<sup>th</sup>, 2022. The federal government has declared a National Day of Mourning and all federal offices will remain closed that day.

Robust Economic
Development
Community Profile

McSweeny & Associates has provided a draft robust economic development community profile for us to review. Bremer walked through areas of concern that she noticed and has asked Council to review and get back changes or recommendations soon so they can be applied to the final document.

Delia School Grand Opening

The Delia School Grand Opening has been postponed as officials are not to attend public sessions during a period of mourning out of respect with the passing of our Queen. The Grand Opening has been rescheduled to be at 10:30 a.m. on October 4<sup>th</sup>, 2022. That date will conflict with the ASB meeting and it was recommended to try changing the ASB meeting to remain on the same day but bumped until 1:00 p.m that afternoon.

ARMAA Conference Update LSD Carlson and CSD Fazekas attended the Alberta Rural Municipal Administrator's Association Annual Conference and were asked to give some feedback. This conference was a different format from other conferences Fazekas and Carlson had attended in the past. Most sessions were presented by member's and there was a higher priority on networking which was very well done and was found to be very useful. They also both enjoyed one presentation presented by a lawyer on dealing with difficult residents.

Michichi Seasonal Camp Sites A coffee meeting has been scheduled for campground residents to meet with County staff at the campground on Saturday, September 24<sup>th</sup>, 2022 at 10:00 a.m.

Policy 130-3

Policy 130-3 allows employees with at least 20 years of service who are aged 55-64 who have retired to remain on Starland County's Benefits plan with a cost sharing agreement as negotiated with County from time to time. This was to assist as the cost of purchasing individual benefit plans at that age could be cost prohibitive. This review was brought to council's attention to see if this was a benefit they wanted to continue.

Attendance

Cpl. Alex MacDonald, Acting Detachment Commander, Drumheller RCMP Detachment entered the meeting at 11:03 a.m.

Delegation Drumheller RCMP Detachment Cpl. Alex MacDonald introduced himself and brought greetings to Council. He is working as the Interim Detachment Commander since June and will continue to serve in this role until a new Staff Sargent is found. MacDonald was interested in getting feedback from Council on what concerns residents have been bringing to their attention. Theft is always a concern, and lately there seems to be an increase of fuel theft. MacDonald recommended residents always report stolen items even if it is something like fuel where they know they will not get it back. This helps the RCMP know what areas are seeing increases so they can adjust their duties accordingly. When asked about their numbers, MacDonald said they had a number of new officers who are currently on probation and that he hopes they will be near full numbers come December.

The committee decided to meet on September 26<sup>th</sup>, 2022 at 10:30 a.m.

Damage Claim Samantha McKee On August 19, 2022, at Hwy 56 and Township Rd 322, Public Works was using a sanding truck to haul gravel. When passing an oncoming vehicle, a large amount of gravel struck the vehicle causing substantial damage to the passing vehicle. Later inspection found the plate in the floor of the box had worn enough to allow gravel to slide through and sit on the rubber mat that covers the conveyor. As the truck went over bumps it allowed the gravel to fall off. The sanding vehicle has since been modified fixing the steel plate, so this is no longer a safety issue.

IDP with Kneehill

CAO Bremer briefly went over the draft Intermunicipal Development Plan (IDP) between Starland County and Kneehill with Council. Council was asked to provide any comments before September 21<sup>st</sup> to prepare them to be ready for a bylaw's first reading at both municipalities.

MRF Delegation Request

MRF Geosystems Corporation has requested to make a presentation on their Lidar Gravel Roads Condition Assessment Analysis program. LSD Carlson and CSD Fazekas gave a quick overview of the positive review received from the CAO of the MD of Provost on how that system gives a very accurate measurement of the quality of every road in the municipality. It would allow Council to develop road plans using data making for more efficient road maintenance planning and reduce road complaints based on opinions. Council would like to hear more about this system and will request a presentation.

Budget Consideration Wash Bay Staff Council discussed the possibility of having a dedicated staff person to be hired where they primarily focus on washing vehicles and general shop clean-up. Currently staff are responsible for cleaning their own vehicles and it was felt a lower wage position could take that work. On the flip side of the discussion, it was questioned if we were large enough to warrant such a position. This will be discussed at our upcoming Budget Meeting.

MD of Bighorn's RMA Resolution

The MD of Big Horn is putting forward their first RMA resolution and asked Starland County to consider seconding their resolution. The resolution addresses concerns where Municipalities are currently taking on the financial burden for providing emergency services, such as firefighting, on Crown land. This is normally covered by the landowner but on Crown land, municipalities are left covering the costs.
