

BY-LAW NO. 839 OF THE MUNICIPAL DISTRICT OF STARLAND NO. 47

IN THE PROVINCE OF ALBERTA, CANADA

A by-law of the Municipal District of Starland No. 47, to authorize the Council of the said Municipal District to charge a fee to members of the public and enforce the collection thereof, for occupancy and use of the facilities located at the Michichi Recreation Area Campground at the Michichi Dam in the Province of Alberta.

WHEREAS it is necessary to provide for a user-fee to be paid by members of the public who make use of the facilities or occupy from time to time the campground located at Michichi Dam aforesaid, and to make other regulations governing use of the said campground by members of the public.

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL DISTRICT OF STARLAND NO. 47 DULY ASSEMBLED HEREBY ENACTS AS FOLLOWS:

1. This By-Law may be cited as The Michichi Recreation Area Campground By-Law.

2. From the date of passing of this by-law the Council is hereby empowered to charge a user fee to members of the public who use the facilities or occupy the Michichi Recreation Area Campground located at Michichi Dam in the Province of Alberta, on the following lands;

That portion of the South West Quarter of Section Nineteen (19) in Township Thirty (30) Range Eighteen (18) West of the Fourth Meridian in the Province of Alberta which lies to the North West of the Reservoir Site as shown on Plan ... R.W. 161, containing Sixteen and Eighty One One-hundredths (16.81) Acres more or less, EXCEPTING thereout the Pipeline Right-of-Way as shown on said Plan R.W. 161 containing Twenty Nine Hundredths (0.29) of an Acre more or less  
RESERVING unto Her Majesty all Mines and Minerals, and

Those portions of the West Half of Section Nineteen (19) in Township Thirty (30) Range Eighteen (18) West of the Fourth Meridian in the Province of Alberta that lie within the water supply as shown on a Plan of Record in the Land Titles Office for the South Alberta Land Registration District as R.W. 161, containing in the North West Quarter, Twenty Two and Sixty One One-hundredths (22.61) Acres more or less and in the South West Quarter, Fifty Eight and Thirty Eight Hundredths (58.38) Acres more or less  
RESERVING unto Her Majesty all Mines and Minerals,

and the Council is further empowered to make such regulations governing use of the facilities and occupancy of the said campground by members of the public as will enable the campground to be operated in a reasonable and cost-efficient manner.

3. The Council is hereby empowered to establish by resolution from time to time the fees to be charged to members of the public and the regulations which, in the opinion of the Council, are necessary to operate the campground.

4. The Council shall post the fees and the regulations, so established, in a prominent place at the site of the Michichi Recreation Area Campground.

5. Every person who fails to pay the user fee, or contravenes any said regulation, shall be guilty of an offence and upon conviction shall be liable to a fine of \$50.00 or in default, five days in jail.




